The physiotherapist is a member of a professional health discipline, whose training and knowledge qualify him/her to make decisions and accept responsibility for all aspects of physiotherapy patient care. The physiotherapist provides effective and efficient physiotherapy services to patients referred to the Parkland Regional Therapy services within available resources. Physiotherapy services will be provided in hospitals, personal care homes, health centers, and client's residences and within community as required.

As a member of a multidisciplinary team, the physiotherapist is primarily involved in the physiotherapy aspects of assessment, intervention, program planning and implementation, discharge planning and follow-up of referred patients. In addition, the physiotherapist is involved in education of patients, family and/or significant other, other health care disciplines, auxiliary staff, and the general public, with regard to physiotherapy treatment, the management of patient's health problems, and preventive physiotherapy techniques.

- Current registration with the College of Physiotherapists of Manitoba.
